Registration Instructions without an Email Invitation from Pinehurst Surgical: (for patients)

If you are using a smart phone you can download the FollowMyHealth app to make this process easier. Also, if you register while at Pinehurst Surgical check your Wi-Fi connection and log on to "PSC Guest."
